RESOLUTION No. 03-08

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA RESOLUTION AMENDING ADMINISTRATIVE AND TECHNICAL REGULATIONS TO IMPLEMENT THE SEWAGE ORDINANCE REVISION

WHEREAS, on May 19, 1998, the Board of Supervisors adopted Resolution 98217 adopting the Administrative and Technical Regulations to Implement the Sewage Ordinance Revision; and

WHEREAS, the Sewage Disposal Technical Advisory Group recommends the Nevada County Board of Supervisors amend Section A-034: Sewage Disposal Technical Advisory Group (1) of the Administrative and Technical Regulations to Implement the Sewage Ordinance Revision to add one (1) Contractor and one (1) realtor voting members; and


WHEREAS, the Nevada County Board of Supervisors desires to amend Section A-034: Sewage Disposal Technical Advisory Group, (1), as follows:

An Advisory Group Will be Established. A Sewage Disposal Technical Advisory Group is hereby established. It is comprised of five (5) consultants, one (1) appointed by each Board of Supervisor, who will serve at the pleasure of that Supervisor and one (1) contractor and one (1) realtor to be appointed by the Board of Supervisors, who will serve at the pleasure of the Board. Each group member will be qualified by experience and training to pass on matters pertaining to sewage disposal. Said group members may not be employees of the County of Nevada. The members may be selected from the County at large without regard for supervisorial district.

The Director shall be an ex-officio member and serve as secretary to the Group, but shall have no vote upon any matter before the Group.

The County Health Officer will serve as a voting member for purposes of the appeal procedure described in Section A-032.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors hereby amends the Administrative Regulations and Technical Regulations to add one (1) contractor and one (1) realtor to the membership of the Sewage Disposal Technical Advisory Group effective immediately.
