To Nevada County Medi-Cal Member,

This letter is to inform you that the **Member Handbook** for the Integrated Behavioral Health Plan (IBHP) of Nevada County Behavioral Health (NCBH) is being updated. This handbook explains how to access behavioral health and substance use disorder services offered by NCBH, and information regarding your rights and responsibilities as a member. The above-mentioned plan has made an update to the **Member Handbook**; the update will go into effect 30-days from the date of this letter, 02/01/2026.

This update for the **Member Handbook** relates to the following types of new services (as applicable) such as, but not limited to:

1. Parent-Child Interaction Therapy (PCIT)
2. Functional Family Therapy (FFT)
3. Multisystemic Therapy (MST)

6. Coordinated Specialty Care (CSC) for First Episode Psychosis
7. Clubhouse Services
8. Enhanced Community Health Worker Services
9. Supported Employment
10. Traditional Health Care Practices
11. In-Reach Services
