Trail Stewardship efforts on all trail easements and preserves in Nevada County was also very busy with vegetation management and general maintenance needs. Staff worked with many volunteer parties to complete this work and got a lot accomplished. Hirschmans Trail, Deer Creek Tribute Trail, Wildflower Ridge Trail, and Alan Thiesen Trail had work parties. Other trails were visited and maintained by our staff throughout this quarter.
